**WHEREAS**, the City of Mankato will be installing a sewer trunk line to the City of Madison Lake in the Spring of 2009;

**WHEREAS**, the new sewer trunk line could be oversized to provide sewer capacity for the sanitary district, which would be significantly less expensive than a separate sewer trunk line to serve the sanitary district;

**WHEREAS**, the sanitary district will not be established prior to the construction of the sewer trunk line from the City of Mankato to the City of Madison Lake;

**WHEREAS**, Blue Earth County desires to facilitate the provision of sanitary sewer service to areas around Duck Lake, Ballantyne Lake, and rural Madison Lake by ensuring that the sewer trunk line from the City of Mankato to the City of Madison Lake is oversized in order to provide sewer capacity for the sanitary district;

**WHEREAS**, the service provided by the subordinate service district shall consist of the oversizing of the sewer trunk line from the City of Mankato to the City of Madison Lake and related improvements to preserve sewer capacity for the sanitary district;

**WHEREAS**, the service provided by the subordinate service district will NOT include the actual provision of sanitary sewer services;

**WHEREAS**, the subordinate service district shall be supervised by the County Administrator in conjunction with the County Department of Environmental Services;

**WHEREAS**, the service provided by the subordinate service district will be financed by taxes, assessments and service charges originating within the subordinate service district, as well as federal, state, and local grants or loans;

**WHEREAS**, after proper notice as required by law, the Blue Earth County Board of Commissioners held a public hearing on March 3, 2009 at 9:30 a.m. in the Blue Earth County Boardroom, 204 S 5<sup>th</sup> Street, Mankato MN; and

**WHEREAS**, the Blue Earth County Board of Commissioners finds that sufficient public support and utility exists within the geographic boundaries of the subordinate service district.

**NOW THEREFORE**, the Blue Earth County Board of Commissioners hereby establishes a subordinate service district for the purpose of the oversizing of the sewer trunk line from the City of Mankato to the City of Madison Lake and related improvements.

**FURTHER**, the subordinate service district shall encompass the areas around Duck Lake, Ballantyne Lake, and rural Madison Lake within LeRay and Jamestown Townships, all within Blue Earth County, Minnesota.

**FURTHER**, a map showing the geographic boundaries of the district, and a list of parcels included in the subordinate service district are available for inspection by contacting the Blue Earth County Department of Environmental Services.
